## 22/266. Council to receive feedback and actions from meeting on 23<sup>rd</sup> February 2023 RE: Concerts Worcester Park July 2023

Decision: It was agreed to set up a working group comprising of Cllrs J Pearce, J Hammond, H Turner and S Hewlett to carry on the dialogue with Badminton Estate and the event organisers to raise the following matters:-

- Entrance to main car park should be from A433 (gate where point to point horse boxes etc use) and not from Oldbury Lane.
- Parked cars should be a minimum of 50 metres from Oldbury Lane and adjacent housing.
- Parked cars should be facing A46 to prevent light pollution into housing backing onto Oldbury Lane (especially as the events are a Sunday night and residents will have work the following day)
- Pedestrians should be directed towards Worcester Lodge Venue and not towards Oldbury Lane
- Ropes to be in place on all road verges including through the village as necessary.
- Controlled access to St Arilds Road and to Creephole.
- Traffic order on A433 from A46 (county boundary) to Knockdown (Sherston turning)
- No access to Badminton Lane but need to secure Village Hall access and access for cricket matches.
- Security patrols within the village with a permanent presence 3.30pm to close.
- Confirmation of license agreement.
- Confirmation of any public rights of way (7 mile walk maybe affected).
- Environmental Health check on sound.
- Adequate protected access for emergency vehicles (especially within the village)
- Litter collection and cleaning arrangements.
- Donation to Parish Council to further fund community projects.

It was generally agreed that there was support for the concerts, but the need for reassurance the organisers will get it right. If they can get it right now, it will only aid the running of any events in future years.

Clerk to advise Badminton Estate and arrange the necessary dialogue.

### 22/267. Update to funding request for a disabled access and associated works to the churchyard pathway
